## SPEECH OF THE DIRECTOR CBI ON THE OCCASION OF ONE WEEK EXCLUSIVE TRAINING PROGRAMME ON "INVESTIGATION OF ECONOMIC OFFENCES & CYBER CRIMES"

Further, the anonymity and connectivity of cyber world have enabled them to criminally exploit the financial systems from far away jurisdictions. India has been consistent in extending hands to strengthen and enrich the law enforcement agencies of its neighbouring countries as well as our friends from African Nations.

We recognize the need to upgrade the knowledge base and skills of the investigators by bringing in new domain of knowledge.

Another formidable challenge in contemporary times, is to track proceeds of crime and forfeiture of assets. The existing laws and protocols have by and large been unable to cope with the complexities and challenges that are spread across multiple jurisdictions. The tough timelines and diversity of legal systems make Criminal Confiscation almost next to impossible. This is a major area which requires greater international collaboration. We in CBI, are committed to contribute to the process of mutual cooperation in all these areas to our fellow developing countries.

To conclude, I would also like to laud the initiatives taken by our Ministry of External Affairs and CBI Academy, Ghaziabad in conceptualising and executing this training programme. I would also like to advise the participants to make the best out of this programme which has been specially conceived for your training needs and freely interact with the experienced faculty, which would be of immense help to them in updating their knowledge and skills. A platform like this will give the participants an opportunity to hone their skills and build capacities.
