

2. Auction will be held separately for each vehicle. The terms and conditions of the sale are as under :-

- (i) The vehicle will be sold on "as is where is basis"
- (ii) Before commencement of the auction, every intending bidder will have to deposit a sum of Rs.1000/- for each vehicle in cash as earnest money which will be refunded to the unsuccessful bidders after the auction proceedings are over.
- (iii) The successful bidder will have to pay 25% of the bidding amount in cash immediately on the spot failing which the deposited amount of Rs.1000/- will be forfeited. The balance 75% amount will have to be paid within next 2 working days of the auction failing which the bidding amount 25% as deposited by successful bidder will be forfeited.
