AUCTION NOTICE

It is hereby notified for the information of General Public that one Hero Honda CD100SS Motor Cycle No. DL-2SL-9409 (MODEL 2001) of CBI/STF/New Delhi will be sold by public Auction on 15/06/2017 at CBI/STF/New Delhi.

All the interested parties are requested to attend the auction and bid for the same. The terms and conditions of sale are as under:-

- (i) The Vehicle will be sold "as is where in basis".
- (ii) Before commencement of the auction every intending bidder will have to deposit a sum of Rs.2500/- in cash as earnest money which will be refunded to the unsuccessful bidder after the auction proceedings are over.
